Dussmann: a partner with a passion for solutions

Dussmann is the largest division within the Dussmann Group. Headquartered in Berlin, it is a partner with a passion for solutions across the segments of Facility Management, Food Services, and Technical Solutions. Our brand promise is “We care for more,” which expresses how we take care of people and the places where they live and work – to make their lives richer and easier.

The Dussmann portfolio encompasses three service segments:

- **Dussmann Facility Management** combines all of the services involved in integrated facility management, with a high proportion of the work performed in-house within our organization: building cleaning, security services, building technology, and charging solutions for electric vehicles.
- **Dussmann Food Services** offers diverse and sustainable dining concepts for children, employees, patients, and guests at senior facilities, all with warm hospitality.
- **Dussmann Technical Solutions** provides industrial engineering and technical service. It has four business units: STS (electrical engineering), HEBO (elevator technology), and DKA and K.E.D., both of which focus on refrigeration and air conditioning technology. All of them create solutions for the entire life cycle of systems and buildings, from planning to installation and commissioning and beyond to service and repairs.

With a focus on innovation, digitalization, and technology, Dussmann develops customized concepts and solutions, all with a focus on customers and their industry-

specific requirements. This frequently produces specialty solutions that are not available elsewhere on the market in this form. Customers include global players in the automotive, pharmaceuticals, and semiconductor industries and from the life sciences, healthcare, and commerce sectors, alongside data centers and public institutions. Dussmann is the biggest division and also the nucleus of the Dussmann Group, an international family company with about 65,000 employees worldwide that offers a full range of services having to do with people. The Dussmann brand is backed in Germany by two companies: Dussmann Service Deutschland GmbH and Dussmann Technical Solutions GmbH.

History

Peter Dussmann founded Dussmann as a company in Munich in 1963. When he did so, he was doing more than opening a small cleaning service. He was writing the opening chapter in a success story. Healthcare facilities joined the customer base in 1968, and he expanded the company internationally. The 1970s and 1980s brought additional services beyond cleaning, including catering, security, and building technology. He expanded the portfolio to include senior care and assistance in 1985. This idea was the start of the second-largest division, Kursana, which now operates 115 homes for seniors. After German reunification, Dussmann opened national affiliates in Eastern Europe. In the mid-1990s, the founder relocated with his company from Munich to Berlin, moving into the new Dussmann building on Friedrichstraße. This is where Dussmann opened the KulturKaufhaus, Germany's largest media store, in 1997. In the 2010s, Dussmann began expanding to technical plant and systems engineering as well, with Dresdner Kühlanlagenbau GmbH (2013), HEBO Aufzugstechnik GmbH (2016), STS Electrical Engineering (2019) and K.E.D. Kälte- u. Klimatechnik GmbH (2021) all adding to the group's range of services. Finally, Dussmann Technical Solutions was founded in 2019 to serve as an umbrella organization for all of the specialists in technical plant and systems engineering.
